
Survey Results & Summary

Sociological surveys were sent out to the residents that live on and around Minocqua-Kawaguesaga Lakes in September of 2006. A total of 834 surveys were sent out and 344 were returned for a response rate of 41% which is generally considered a high rate of response for a public opinion survey.


Below is a summary of statistical survey results. There were a number of areas on the survey that provided space for additional comments. These comments are also included at the end of this report.

Background Data:


About 75% of survey respondents are year-round or seasonal residents. About 25% are non-residents.




The vast majority of respondents live on Minocqua Lake, while about 28% live on Kawaguesaga Lake.




A majority of the respondents have been living on or visiting the lake for over 20 years.




About half of the respondents described the lake water as "clear", while the other half described a negative quality such as "cloudy" or "bad odor".




For the majority of people, the description of the lake water quality was determined by their ability to see the lake bottom. Others claimed that the amount of algae and aquatic plants or the thickness of the sediment/mud determined their response.




Of respondents who fished during the past 12 months, very few thought that the quality of fishing has improved over the last 5, 10, or 20 years. However, as they looked further back in time, there was an increase in the percentage that thought fishing quality has declined.




Slightly over 34% of the respondents (50% of those that fished) felt that the quality of fishing in the past 12 months was worse than the previous 10 years.



Less than 5% of the respondents felt that the fishing was better in the past 12 months compared to the previous 20 years.




Most survey respondents think there are about the right number of public boating access points. Over 40% think there are more than enough public boating access points.







About 55% think the lake's health was about the same in the summer of 2006 compared to the last year, while 35% think the health has worsened.




When asked to look back 5 years, respondents who think the lake's health declined increases to 49%.




Looking back over the past 10 years, about 51% of respondents think the lake's health has declined.




Slightly less people think that the lake's health has worsened over the last 20 years than think it declined over the past 10 years.




About 43% of respondents would support the creation of a lake district in order to take care of the lake. 26% would not and 25% are unsure.



About 49% of respondents have shoreline landscaped barriers to reduce erosion or runoff, 66% have undeveloped, natural shoreline vegetation.




The vast majority of respondents have no plans to take additional steps to control runoff.







70.2% of respondents think that fertilizers from lakeshore homes causes or may cause water quality problems for the lake nearest to them. Almost 82% think problems are caused by aquatic plants from other lakes. The other factor that is largely considered detrimental to lakes is septic systems.




Most people are aware of chemical treatment of EWM (Eurasian water milfoil) done by the Lake Protection Association. Other efforts are recognized by less than half of respondents.




24.5% of respondents are in support of a 35' vegetative buffer along their shoreline to reduce runoff into the Lake, while 43.6% oppose this.




The vast majority of people support using fertilizer that does not contribute to increased algae in the Lakes. Only 2.6% of people oppose this measure.




Many of the methods below to improve water quality are deemed necessary by over half of the respondents, including: fertilizer ordinance, zoning & town ordinance, education/information, monitor water quality, financially support programs, and reduce erosion off boat landing.




Respondents think that the state government more than any other group should be responsible for financing actions to improve the lakes. Next, the respondents think responsibility falls on the shoulders of the township government, the lake protection association, then the county government.




About 67% of respondents would support the use of chemicals to control invasive plant species such as Eurasian Watermilfoil.



The majority of respondents—over 65 percent—believe that the amount of aquatic plants have increased over the last 15 years.




Over 75 percent of respondents believe that controlling aquatic invasive species should be a top priority for the Lakes Association.









Comparing this chart with previous charts, it is shown that entertaining friends, fishing, and swimming are done by many people with low frequency.






The majority of respondents feel there is a problem with the amount of green algae on the Lake.




An overwhelming majority of respondents feel the Lake is an important resource to Minocqua and surrounding communities.




65.4% of respondents would like to see some control of personal watercraft, 16.9% would not be in support.




Many respondents do not agree with the statement that water quality has improved in recent years.

 - "Do something to control swimmers itch."
- "We pay very high property taxes living on a lake; this \$ should be the source of any remedial expenditures. Additional assessments should not be considered."

"I will probably join in the near future."

"This group has too many busy body out in left field people. Public waters are not the property of the MKLP, but are state owned and the responsibility and control must rest with government not with any association (to often guided by personal considerations)."

"I believe the biggest problems are: green algae blooms in parts of Lake Minocqua caused by fertilizers containing phosphorus and failing septic systems; overpowered and oversized boats on chain causing excessive noise disturbance and disruptive wakes; invasive weed species."

"The lakes are failing rapidly. When can we start doing something besides paying people like you to do surveys? We study everything to death. Raise taxes, etc. Do something to get the money and take action."

"Back in the 40's, the weeds from Trophy Park to the island were so thick we could lay on them. Then they moved the sanitary system to the river (the thoroughfare was the same). They slowly disappeared. I think sanitary systems and boats coming in to the system are causing most of our problems – mostly outsiders. The people here are new and the number has caused a lot which doesn't help."

"We support Lake Associations to work towards improving lake water quality, however strongly oppose associations imposing restrictions to residents and users of the lakes. The association should direct efforts upon the DNR to do their job and fund these projects. See Question #13c. Why do we get grants to study watershed from the DNR. The DNR should be conducting the study at their expense. #13d – why isn't the DNR developing an Aquatic Plant Management Plan? #3b – why isn't the DNR monitoring the lake water quality? The more the association does, the less the DNR will do. It is time to push the DNR to properly manage the Natural Resources – our lakes."

"I am also disabled."

"The association would get more people to join or support it if it took a stance against excessive use of PWC's and excessively large and noisy power boats. People who reside on the lake or have second homes on the lake, seem to constantly complain about early morning and evening overuse of PWC and extremely loud boats while the association seems directed only at water quality thereby not getting many excited enough to join or support the organization, which is received as a one issue group."

"Limit skiing, tubing and PWC to 10 a.m. to 5 p.m."

"Increase water level in Minocqua Lake. I purchased home in 95, water level is 2 feet lower."

"It is extremely important to monitor water quality and invasion species and to control them."

"I want to improve the water quality of the lakes as well as the fishing. I don't feel that all of the financial responsibility should be borne by the property owners. We have paid for the land, pay taxes, and the majority of the problems are a result of the public boater using the lakes for free without care or consideration of others."

"Why do people who do not live on the lake have piers? If that's ok, then why can't every property owner have one? I oppose piers on public land for private use. Condominium development too aggressive. More regulation of lakeshore needed."

"The height of the water table needs to be more consistent. I know there were droughts the last two years, but there is no reason the dam needs to be open during these times."

"I wish there was something we could do about the few high horsepower boats whose owners seem to just enjoy flying along the shore with their loud roar and annoying every animal and person on the lake."

"What ever problems you have with the lake should be taken care of by the DNR. We do not need another form of government."

"Awareness of public involvement of public laws to govern lakes with teeth. Get state involved. Enforcement – enforcement, etc. Monitor – monitor, etc. Get everyone involved or our land value will suffer."

"Financial needs should be shared by all using/benefiting from lake residents, non-residents, boat landing fees, snowmobiles, ice fishermen (previous two with fees at access points or annual user fee). Business community likewise share costs."

"I have 20+ years experience as a water treatment chemist with a strong understanding of the use and mechanisms of biocidal agents used for biological control."

"Question 12:15 wooded to cause a predetermined outcome. Question 16-A-B-C is meaningless without specifics of the ordinance."

"The water level in the last 3-5 years is so low that boat access to pier is difficult. Frogs are disappearing, herons, fish spawning along shore, etc. If the water level is down, why let the power company keep draining the lakes for their use downstream? Also, leave the Canada Geese alone."

"Having one set of erosion control rules for all property owners doesn't make sense. A lot 200 feet deep that is level at two feet above the lake level should have different rules than a lot with a steep bank that drops 20 feet at the lake edge."

"Thank you and everyone for their work and interest on this very important matter. Too many boats with large motors all times or day."

"Water traffic continues to increase. Water ski activity sometimes goes from 7 a.m. to 9 p.m. Non-motorized boat use is impossible during this time. Increased condominium construction puts more boats on the lakes. We are facing an overcrowding situation. The natural beauty of the area is being sacrificed for economic gain."

"Probably the most disruptive and chaotic lake activity is due to jet skis. Besides the constant noise, the all day back and forth activity riles up the lake to unacceptable levels. On cooler days when that traffic is nil, the water clarity is very nice. Jet skis also contribute to safety issues as they rapidly and randomly change course during high boat traffic periods."

"The biggest change has been the increase in milfoil. But the water quality is still good. Do not have 35 feet along shoreline to act as buffer."

"I would like to see water skiing limits such as time lines."

"This was sent to my son, but he lives in Texas and couldn't answer most of these questions. He and his siblings own some of our property in a trust. Keep up the good work."

"We were not properly warned about this spring's chem. treatment."

"Jet skis are getting more like power boats. Much larger and quieter. Very nice looking watercraft."

"This survey should have had MKLPA return address on the envelope – I almost threw it away thinking it was junk mail. Because the DNR thinks they are God Almighty, they should be financially responsible for water quality. I do not see farms and land owners paying for CWD deer problems. DNR waste too much money on unnecessary projects. I think a lake district would be financially uncontrollable just like a technical school, as far as taxing goes."

"Shouldn't the boater (those towed in)/fishermen be taking more responsibility for the preservation of our water. Let's press that above charging more taxes. Thanks for all your time and work. It is worthwhile."

"Over the past 10-15 years, fishing quality has steadily declined. Water quality over the last 5 years is worsening. Lake system is asset to community, county, state – lakeshore owners already pay high price in taxes – lake quality is issue to be addressed by state, county, community."

"This natural resource can't be replaced. It adds value to the community."

"Lake Minocqua is used by the public and as such the cost of protecting the lake should be shared by all users, not just those who own property on the lake."

"Numerous studies have shown septic systems are leaking into the lake. No restrictions have been placed on boats with motoring fouling the lake. No restrictions have been placed on jet skis operated by inconsiderate people visiting the lake. The DNR should concentrate on protecting the lake

rather than deciding on the color of the houses near the lake or rather than making rules limiting flag poles or benches on docks."

"We're completely in support of a lake district, however we are strongly in favor of the majority of money to be used on projects, not administration. Using volunteers will continue a sense of ownership, while paying people creates separation."

"Would like info on weed control and water levels."

"There should be a charge (or a yearly user fee such as for bike trails) for launching boat at our boat landings and this money should be used for lake improvement projects."

"Already very involved."

"Fees needed at boat landings for non-resident users. Should fund steam or high pressure washers before putting in boat. You need a shower to enter a hotel pool and trailers should be cleaned too. Guides and heavy fishermen are introducing invasive species – need to be controlled. Lake perimeter needs to be sewered."

"Please try to have a speed limit and a noise limit imposed on all watercraft and be enforced."

"Could you have more patrols especially on holiday weekends. The lake is getting much more busy and dangerous to be on while boating. Many close calls cause of speed and alcohol I'm sure. Cut down on fishing tournaments and please lower taxes so I can afford to keep the cottage. We're not all Chicago Milwaukee millionaires."

"This year I noticed for the first time in 21 years that: 1) the water clarity was the worst ever (couldn't see 4 foot); 2) first time ever saw algae bloom in front of my house; 3) there was a heavy layer of dead plants on lake bottom. Also, for the last two years, the water level was below normal lake levels. Is this a factor affecting water quality. Can the association discuss with WPS to not drop lake level in spring as they normally do. I assume WPS has the authority to drop the lake level."

"We need to become a lake district so we have better control of the lakes problems."

"Enforce boating regulations. Limit boat rental places use of landings. Better landing ramps and parking."

"Water level of lake is lower each year – strongly disagree with current level."

"We have a 23 foot natural buffer to the lake. We use no fertilizer. We have a new two year septic system, 75 feet back from the lake."

"Dissolved oxygen measurements in Minocqua to Kawaguesaga deep holes, July 2006, indicated that the bottom third (depth) of both lakes were devoid of oxygen. Hydrogen sulfide was in samples of bottom water. A top notch limnologist stated that he feared that the lakes are going belly up (eutrophying at an accelerated rate). Once a lake goes eutrophic, it is exceeding difficult to reverse the process. The time to act is now."

"Boat landings – Brunswick Road – needs attention (in water). Boat trailers nearly tip over (uneven). Large berm (with rock) off pier end. Needs better slope."

"Regarding personal watercraft usage on the lake. The problem lies with people on them not following the rules of navigation. In addition, the usage by underage operators contributes to the problems of not following the rules of navigation. Thus, better enforcement of boating laws."

"The DNR doesn't allow you to do anything (piers/docks – retaining wall), so the DNR should be responsible. They built the boat landing that brought milfoil, etc. Jet boat/jet skis (PWC) do not following boating rules and are extremely noise. Patrol the lakes more, enforce speed/noise laws (make speed/noise laws). Enforce 100 foot buffer. There is more pollution from the bridge and island than from everyone on our lake combined. Also have slow no wake through the thoroughfare. Nothing there is 100 feet from shore. Boating should be leisurely, not racing (here). Part no wake and part without leads to problems and ill feelings."

"Water quality in Huber Bay is terrible. Aquatic plants have taken over the bay. Please try to correct these problems."

"We are not there on a regular enough basis to volunteer at this time."

"I think a flat fee per household to support your work would be ok. I'm not interested in a mil rate based on value of home. Also, this lake is used by the general public. I think the county or state should pay the bulk of the expenses. I have a rather large home on the lake and I bought the cottage next door. They are on separate tax rolls. The two houses are used a total of about 150 nights -25 for guest house and 125 for main house. I pay \$20,000 in property taxes the land alone is assessed at \$2000 a foot x 380 ft. = $\frac{1}{2}$ my taxes. I'm happy to pay my fair share. Hopefully not two shares because of the two tax bills and not a % of my taxes. I don't fish and use the lake for pontoon rides only."

"We feel that a properly funded association can greatly enhance the enjoyment value of the lakes."

"We think that not only controlling invasive plants already here, but stopping the reintroduction of them into our lakes should be our #1 concern."

"We appreciate the work of the MKLPA. We also enjoy boating and snowmobiling. There are already laws about hours of operation for jet skis (not after dusk). We feel all of these things – boating, skiing, swimming, drew us to the area, and now that we have a home there, would it be right to deny others those same pleasures? We do not use fertilizers, we recycle, and are willing to do other things that would protect the quality of the lake without denying ourselves or others the pleasures of the area. Whatever else may be happing in the area – the eagles have increased, the loons are still present, hummingbirds, woodpeckers, blue herons, so many birds – still find the area conducive to their needs. What may be less conducive to the pleasures of the area are the lights from town that affect our former ability to see stars and the northern lights. Ironically, improved water quality may draw more people, which draws more business, etc., etc."

"Keep up the good work."

"The depth of the water for the past two years has been terrible. I do not understand why they are draining it so low."

"Bring the water level up."

"As a taxpayer in Minocqua, we get very little for the taxes we pay. Nothing. There is no service that we receive. We feel the taxes we pay should fund or contribute to the monitoring program. People from out of state should be responsible for contributing as well (the people from out of state who visit, use the lakes, etc.). Visitors from out of state who use the public launches should pay launch fees."

"My son worked for a business that sells gas to boaters. He said there are frequent spills. These spills are allowed to dissipate rather than performing clean-up. Can you work with these businesses on finding solutions. Perhaps a noise ordinance to discourage exceptionally loud motor bots from our lakes."

"I think getting this survey out is a good start to educating people. There is an organization concerned with our lakes."

"Wisconsin valley improvement and the DNR should clean up Kawaguesaga for they were the ones that forced to have the boat landing put in by the dam which was opposed by many, many people and the MKLPA Association – that brought milfoil in our lake in less than 3 months. So they should clean it up."

"Prohibit phosphate fertilizers use in the Whole state, as is in MN. Also, a portion of state lotto sales to be used for lake protection, stocking - \$ tourism."

"Wisconsin is already one of the highest taxed states. Therefore, any additional taxes would not be welcomed. As a summer resident, we pay taxes, but we should be allowed to vote in local elections put on tax increases."

"Many now call our lake the sewer – that should attract lots of tourists – please investigate. Natural clean-up methods and continue monitoring and require boat washing and inspections at a fee prior to launch. Be assured these things will not deter tourists."

"Stop the continuation of multiple housing units on our lakes. Stop approving condo's for one thing."

"Control water levels – they are too low."

"The fishing in general has worsened over the last 20 years dramatically due to Indian spearing, milfoil, and general quality of water. Also, the water level needs to be held at a higher level. Also northwest end of Minocqua needs to be dredged. Dredging, weed control, and water depth will help a great deal."

"Just had triple bypass heart surgery."

"We don't need anymore individuals or organizations attempting to dictate our lifestyles and how we utilize our property. Lower water level. Drought and the Wisconsin River Valley authority's draining have contributed to this problem for past five years resulting in more plant growth."

"Too much fishing pressure. Needs more stockpiling. Less tribal abuse."

"My wife and I own three lakefront properties on Lake Minocqua. Two properties are connected to the lake land sanitary district #1. I am making application for the third property. Expansion of the sanitary system although costly would seem to be a progression."

"Again, use your time or better projects. It's a social group trying to look good."

"I think it would help to put a no wake marker in the bay at south end of the Lake Minocqua because it is very small and boats water ski in and out of it all the time."

"Has expansion of municipal sewer been considered?"

"Water level has been very low the last two years. A lot of snow and rain has been adequate for other area lakes/chains from talking to and personally used these waters. Not sure why so low lately? I would also start a fee system for boats and inspection if possible at landings. More info. about milfoil at landings."

"Keep up the good work."

"I live in Milwaukee most of the time, but believe two things would truly help. 1) elimination of septic systems; and 2) only use fertilizer ok for water."

"This is a good survey. Keep up the good work."

"I am opposed to a Lake District after hearing the presentation at the annual meeting. This is another level of government we would impose on ourselves and the taxes to go with it. Minocqua is dependent on tourism related to quality lakes for its existence. There is no other significant industry. The town/county should aggressively fund these activities because all have a major stake in lake quality...not just the lake property owners. I have no direct benefit from the schools, Christmas parade, etc., but still pay outrageous taxes to pay for them. The town as part of its government structure should establish a Lake Quality Committee and a segment of the annual budget to support it. The MKLPA should be represented on this committee. Funding would be broad-based and complete with all of the other requests for tax dollars. At the annual meeting, those who have not joined MKLPA were called free-loaders. I say that they have not been successfully sold on the value of membership and this should be the strategy rather than forcing membership through a lake district."

"I have owned lakefront property for three years and I am not sure if there is or isn't a problem on our lake."

"We need great quality, but not at the expense of use by owner."

"Every business in the township benefits from the Minocqua-Kawag. Lakes. That's why I feel the town should pay for water quality work. I already pay the town about \$5,000 per year in taxes and receive almost no services for that. Every citizen (including non-lake owners) also benefit from the lakes by the tourism business and jobs, that's another reason to have the town pay for lake water quality. Keep in mind that there are other nice lakes in northern Wisconsin and upper Michigan to compete for the seasonal residents and tourists."

"We love using the chain of lakes and we appreciate efforts being made to sustain its beauty. We have experienced the Lake Geneva style large boat invasion in the summer. This invasion should not be allowed – it will be the number one reason these lakes will fail."

"The increased use of personal water crafts and certain types of boats have had a profound impact on the lakes. The quantity of vegetation has changed as a result of these craft being too close to shorelines and entering shallow areas with the intent of generating larger wakes. Lake health is greatly dependent on the vegetation present."

"Good survey."

"Lake District fees should not be based on property values."

"Water levels – down about 16" this spring – now Sept. still 10" down – more no wake zones – it's dangerous out there – more time restrictions on some activities – the lake needs quiet time too – to recover from excessive activity."

"Major increase in shoreline weeds floating in from the lake."

"An obvious problem is the ever-increasing amount of filamentous algae present in those lake areas away from the current existing into the Tomahawk River."

"Please don't get into areas that cause controversy. The peace and quiet of the northwoods should include freedom from constant controversy and people trying to force others to do what's good for them. Oneida County has already created enough problems with its attempts to improve zoning. Monitoring, advising and trying to convince people to voluntarily do things is fine, but please don't go beyond that."

"Question #12. Residential property should have enforceable regulations on rentals. We see homes being rented out weekly and even daily – with 12 to 20 or more people occupying a 2 or 3 bedroom property. Now that is putting a lot of stress on septic systems and it's going on into the lake."

"Will have more time to participate in volunteer work in 2009."

"Our home on Lake Minocqua is currently for sale. We're moving because the lake has become to busy and noisy."

"I think implementation of a launch fee should be instituted so all users will have a way of taking care of the resource."

"Thank you for the survey. The quality of the Minocqua/Kawaguesaga chain (incl. Min. & Tomahawk) is very vital to community, tourism, etc. Perhaps consider a nominal annual license for all who use the lake for additional funding of costs for the greater good."

"Full time residents would be the best to be on board of MKLPA as they are aware as to what is taking place and what problems arise."

"Creating a lake district is very important to me."

"I believe that the State of Wisconsin is responsible for the health and care of public access lakes. I would be happy to do whatever I can to promote and encourage that. Please send me an application for membership in the KPLPA."

"I have my own wellness business. I have non-toxic home products that would be great for lake homes. I use non-toxic laundry products as well. I would be happy to share this info. by mail or a speaking engagement to help people understand what goes down the drain is very important to our environment. These products also are better for septic systems."

"Spend more money on patrols, not just driving around watching fisherman and their garbage. People cutting down trees on shoreline for their homes. No more condo's. This bring in more people and speed boats and skis. Use money for patrolling and not your pockets. This is deer and bear country – not dog country."

"Lakes are down foot or better what the problem, over 2 years."

"The lake is what makes Minocqua such an enjoyable place. Our family has great many memories at the lake. We are very concerned with runoff from the manicured lawns and the water quality."

"Lake Minocqua is a recreational lake and will never be a wilderness lake. Therefore, I feel it is unrealistic to expect to enforce a bugger zone of natural vegetation. The best we can do is to control invasive species through education and as necessary chemical means. I believe the fishery has actually

improved through the practice of catch and release. Formation of a Lake District would ensure that all lake owners share in the cost of maintaining water quality."

"I would be interested in understanding the goals and direction of the association."

"Over the past 10 years, our family has experienced increasing incidents of swimmers itch. Each year we report to the DNR – each year they claim no reports have been called. It gets worse each year. No one swims on our side of the lake – Minnesota and Michigan lakes have successfully treated this with chemicals. I feel it is a serious threat to our lake."

"The lakes are overcrowded. Too many big boats. Noisy jet skis. Too many condo's (people). Fishing tournaments kill fish."

"This is a family vacation home shared by three families."

"I think as far as water pollution, get rid of the rentals of jet skis on the lake. These two stroke machines really put off a lot of smoke into the water. I think instead of patrolling bikers on the Bearskin Trail, they should put these people to work at the boat landings to insure that motor testing and other contaminants are not going into the lakes."

"Over the past 20 years, Lake Kawaguesaga has been increasingly polluted by only residue from combustible engine exhaust. Also, noise pollution has increased dramatically due to inadequate mufflers on large power boats and personal watercraft. During the summer months, Beer Can Island has become a public beach with typically 15 to 20 boats, pontoons and personal watercraft spending the entire day with no sanitary facilities available so the lake is being used as a septic tanks of convenience. Traffic and related wave action is incessant. Escape to the northwoods has become an oxymoron. I have complained to the DNR, but to no avail. There is no control over the use of the island.

"Controlling purple blue str. along Lake Tomahawk channel should also be a priority along with eurasion milfoil and curly pond mill weed."

"The current group has done an excellent job to alert the public re: the condition of our lakes. I feel the state – namely DNR – could do more to assist with lake problems – with advice, with money and with personnel."

"I have been a seasonal resident (lake front property) for 26 years. Although I am sure you are well meaning, the meetings I have attended are unimpressive. Too many environmental hand wringers and not enough practical application, which takes property rights into consideration. We purchased lake front property, for a premium, and pay taxes that are substantially higher than our inland neighbors. I am tired of the continuing restrictions we face year by year by the DNR and others. God created the beautiful place for us to enjoy and care for, but not to worship, as some of your members expect. For now, count me out."

"We are in the area only on weekends when possible and makes doing things difficult to keep up with volunteering time."

"This survey concerns me because it gives the impression of slanting toward drastic controls and limitations of personal freedoms instead of preservation of the lake."

"We are constantly told that all of the State's lakes are held in trust for all of the State's citizens. Fine, then make all of the State's citizens pay without the need to kiss Madison's and the DNR's butt every time something needs to be done that costs money."

"This is like closing the barn door after the horse was stolen. It was quite obvious that creating a boat landing would be followed by invasive species. Now we are faced with a tax to correct a situation which might have been avoided in the first place. Further, this is tantamount to taxation without representation. Since there is no public choice as to who is doing the taxing, let the DNR do it for our tax money already supports that organization."

"I thin the vegetation boarder on shoreline is very important, but continue to see very green lawns come right to the shore. I notice local stores stock very little K-free fertilizer, so people must not be asking for it. Maybe more education is necessary."

"You do wonderful work. Creating a lake district would be good."

"Over the years, I have noticed two disturbing trends: 1) the lake clarity has been, and still is decreasing; 2) the number of red bumps and welts I get from entering the water has been increasing to the point where now, every time I go swimming, regardless of the time of year, I will get some swimmers itch or something similar."

"I agree that water quality has become an issue but I strongly disagree that lakefront owners should bear the cost of this issue. Minocqua is nothing without this chain of lakes. This issue would affect the whole tourism industry of Minocqua, i.e.: restaurant owners, hotels, local businesses. I feel that this is a much larger problem for many people besides property owners. The waterways are open to the public so the public should help maintain them. If it came down to only property owners bearing the financial burden, then I would say shut down the public landings. Maybe if people were held fiscally responsible for their actions, they may be more respectful and aware of the effects they may be having on the lakes."

"No additional taxes."

"There is no way we should be taxed more for living on the lake. Start a landing fee and have everyone who uses the lake pay."

"We need to find a way to set a fee to launch/use the chain – to assist in paying the discussed costs."

"I appreciate all you are doing."

"Think we should control access to the two lakes with fewer landings and pressure wash boats to remove undesirable items prior to boat being allowed to enter lake. Should change for use of lake if not a property tax payer on the lake. Should have pre-addressed the return envelope – not doing so probably reduced participation."

"The formation of a lake district is very important in order to accomplish our task of maintain good (high) water quality. However, all lake property and watershed resident owners should share the responsibility."

"Lake pollution – the high ranking contributors, 1) septic systems old and outdated; 2) runoff from roads (oil, gas, salt and other climates); 3) boats with motors; 4) dumping down the storm sewers; 5) fall leave/tannic acid. Just one helpful tree – oak absorbs into its root system – magnesium, calcium, potassium, nitrogen, phosphorous, and sulfur."
